and Conditions**

- **This event is an exhibition and not a competition. There are no prizes or awards associated with the exhibition.**
- **The exhibition venue is the Art Space, St. Patrick's University Hospital (SPUH), Dublin-8.**
- **Eligibility: The exhibition is open to service users and staff of St. Patrick's Mental Health Services including St. Patrick's University Hospital (SPUH), St. Patrick's Lucan, Willow Grove, Dean Clinics and Associate Dean Clinics. This exhibition is not open to family members or relatives of service users and staff.**
- **Theme: The theme of the Exhibition is "Anything Goes".**
- **Categories: The following categories are allowed: painting/drawing/ (oils, acrylics, water colours, pastels), graphics, poetry, 3D (pottery, sculpture) and mixed media.**
- **Maximum of two entries per person and have artist name and title of art attached to back of artwork. The maximum allowed size is A3 (297x420 mm) or similar on canvas. Entries can be framed by the hospital using IKEA frames if requested. The artwork will be returned unframed or if sold, the cost of the frame will be deducted from the selling price.**
- **Jury: Each entry will be juried by the art committee using a standard criterion. a panel comprised of the Chair of the Art Committee, Representative from SUAS, two Members of the Creative Department, Communications Manager and/ or designated representative using a standard criterion. The Art Committee, on behalf of SPMHS reserves the right to not accept works that it deems may be considered or construed as distressing or inappropriate in consideration of the location for the exhibition. If the jury is unable to accept a submission contact will be made with the exhibitor to offer him/her the opportunity to submit an alternate piece for the exhibition. All decisions of the jury committee are final.**
- **Format: Works must be original. Works that have been previously displayed in any SPMHS exhibition will not be accepted. All work must be clearly labelled, mountable, and exhibition ready.**



- **Liability:** Every precaution will be taken from the time of receiving until the return of entries, but SPUH will not be liable for the loss or damage of artwork from any cause.
- **Hanging and installation arrangements** are at the sole discretion of St. Patrick's University Hospital. Work will be presented as submitted.
- **There is a presumption that all works accepted will be displayed.** If for any reason, we are not in a position to exhibit your work we will make contact with you and offer you the opportunity to provide an alternate submission. If we have not been able to display your submission, we will return it to you.
- **At end of exhibition the exhibited works should be collected by arrangement, please note that uncollected works can only be held for 3 months maximum.**
- **Privacy statement.** All information will be for access by Art Committee members and is for identification of artwork and return of artwork at end of exhibition. Service users will have full control over their privacy and are not required to provide personal identifiable data if they so wish. This data will be held for five years and securely deleted upon expired retention period.
- **Please only deliver art works between 7<sup>th</sup> and 21<sup>st</sup> of October to St Patrick's Hospital. Unfortunately work submitted after the 21<sup>st</sup> of October cannot be accepted.**
- **There are no prizes or awards associated with the exhibition. However, some of the artworks in the exhibition may be made available for sale. Buying and selling of exhibition pieces will be the responsibility of the artist. Artists are asked to indicate on the entry form if they wish for us to share their contact details with interested buyers.**
